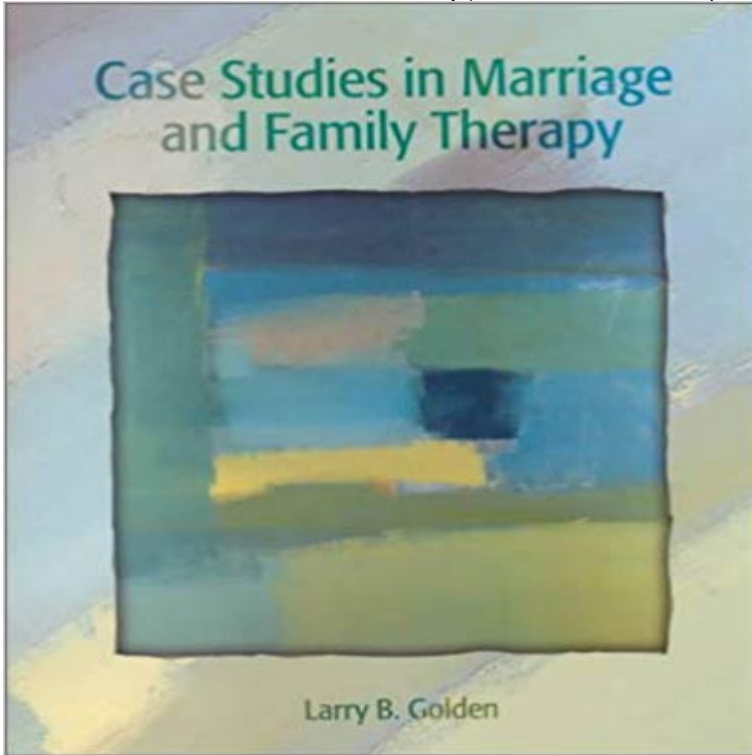


Case Studies in Marriage and Family Therapy
